### **Executive Director's Corner**



In a recent academic literature review by the Virginia Center for Housing Research identified that affordable housing creates positive academic outcomes for students as much as it *reduces* forced mobility, overcrowded conditions, health consequences of substandard housing, insufficient income, and parental/family

On May 17th, the Board of Commissioners voted unanimously to award the Authority's first scholarship to Grace Toto, a Harrisonburg City Public Schools senior.
