# Housing Choice 🔗 Voucher Updates

HUD has implemented new inspection standards to guide housing inspectors. These guidelines ensure accurate and reliable safety inspections across the board. The National Standards for

the Physical Inspection of Real Estate (NSPIRE) prioritize health, safety, and function over the appearance of rental units. These standards go into effect on October 1, 2023. Landlords with rental units occupied by housing choice voucher holders will be required to adhere to these standards as mandated by

HUD. The main objective of these new resident-centered standards is to ensure that residents live in safe and sanitary conditions. We welcome any questions or concerns you might have. You can reach us by emailing

Staff is also focused on improving community engagement through our Kelley Street Garden dinner, youth summer reading contest, and planned community partner and resident recognition banquet in the fall.



# Staff Highlight: Victoria Hill

HRHA manages a variety of programs, grants, and initiatives. We serve hundreds of families through housing vouchers, programs like Family Self-Sufficiency, and city-wide campaigns. Through 2023, we plan to highlight members of the HRHA team who make this work possible.



#### 1. What is your role in HRHA?

I am the Resident Services and Communications Coordinator for HRHA. I manage the housing authority's website and social media page. I have the wonderful opportunity to oversee the Kelley Street Garden, and I am a Family Self-Sufficiency Coordinator assisting participants and coordinating FSS events and activities.

#### 2. What is an important skill a successful professional should have?

An important skill to have is the ability to collaborate with others. Through collaboration, whether someone is developing a project or using problem-solving skills, having other team members to work with allows you to see and hear about others' points of view. This is also a vital learning opportunity to hear the perspectives of others with expertise in a specific area and learn from their experiences.

In my position, I aim to help as many participants as possible reach their goals. I enjoy collaborating with my colleagues and community partners to bring knowledge and exciting learning opportunities to our local community.

# 5. What do you wish more people in our community knew about affordable housing, our families, or the voucher program?

I hope that awareness about the Family Self-Sufficiency (FSS) Program spreads within our community. Since HRHA has become a Move to Work Agency, our FSS program has seen several positive changes. Participants in this program are given flexibility that allows them to select from pre-outlined goals under topics such as education, financial, homeownership, and work activities that help bring them closer to self-sufficiency. The goals themselves help bring others closer to self-sufficiency, but even more so, these goals are connected to cash incentives. So once a goal is completed, money is rewarded! These funds can help with immediate expenses but also help contribute towards long-term goals such as savings for a down payment on a home.
