#### Executive Director's Corner





The voucher program is the only way that some people are able to afford housing and not be on the streets.

#### 6. What is the best career lesson you've learned so far?

The same lessons I learned in my previous work apply here as well. Treating others with dignity, compassion, and patience, no matter what their story is, and never assuming that you know what someone has been through or is going through.
