The HRHA Scholarship Application is Now Open!

We're thrilled to announce that applications for our college scholarship are now being accepted! In March 2023, HRHA proudly awarded a 4-year, \$4,000 overall scholarship to deserving high school seniors who receive housing assistance. This achievement was made possible thanks to the generous support of our local community through the Great Community Give fundraiser.

Scholarship recipients will be selected from HRHA residents or voucher holders who have maintained their HRHA residence for at least six months before April 28, 2024.

The scholarship provides \$500 per semester, up to \$1,000 per year, and is renewable based on continued eligibility. Don't miss this opportunity!

Executive Director's Corner

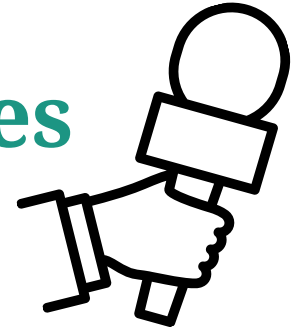
